

ADMINISTRATOR OF THE YEAR AWARD

The Nassau BOCES School Library System is pleased to announce its intention to honor educational administrators in Nassau County who have made a significant contribution to school librarianship.

Criteria

The award will be given to administrator or administrative team working in an educational setting in Nassau County. School library media specialists are not eligible.

The guidelines to be considered are:

1. Supports the Plan of Service of the Nassau BOCES School Library System
2. demonstrates policies and procedures for the advancement of school libraries/librarianship
3. fosters growth of school library media specialists
4. exhibits educational leadership
5. exhibits understanding of current practices, has a vision of future trends, and works toward implementing that vision
6. exercises a high degree of effective interpersonal skills while maintaining a high standard of professionalism
7. instrumental in seeking funding to improve library programs.

Selection

The selection of the award winner will be determined by the NBSLS Administrator of the Year Committee and approved by the Council. The committee, selected by the NBSLS Council Chair, is composed of at least 5 persons, of whom not more than 2 are current Council members. A former recipient may be a member.

Nominating Procedure

Nominations may be submitted by NBSLS member library media specialists and Council members. A nominee or a nominator shall not be a member of the selection committee. The Nominating Form, and a descriptive narrative encompassing the criteria above should be submitted in writing. The narrative must be typewritten and not exceeding 500 words. The specific contribution(s) that the nominee(s) have made toward school libraries or librarianship should be highlighted. All nominations should be sent via E-MAIL to Barbara Neist no later than February 12, 2010.
