### Terms and Conditions for Use of the Wireless VLAN

1. I certify that I have installed the most recent operating system security updates on my personal equipment and agree to continue this practice when using the district's wireless VLAN.
2. I certify that I have purchased and installed current antivirus software on my personal laptop (Windows only) and agree to update it on a regular basis.
3. I certify that all software and files on my personal equipment have been purchased and legally licensed for use in compliance with copyright law, and agree to continue this practice when using the district's wireless VLAN.
4. I understand and agree that I will not use my personal equipment on the Wireless VLAN to transmit any illegal or inappropriate files or partake in any illegal or inappropriate online activities.
5. I understand that the Wireless VLAN is designed to provide wireless Internet access and may have limited access to other networked district resources.
6. I agree to submit my personal equipment to district technical support or school staff upon request for initial setup and ongoing compliance with these guidelines.
7. I understand that my equipment can only be connected wirelessly to the district network using the VLAN that was set up for this purpose and not through any other wired or wireless connection.
8. I understand that technical information about my personal device may be logged when connecting through the Wireless VLAN to GNPS systems.
9. I understand and agree that my equipment will be filtered for Internet access in the same manner that district owned computers are filtered on our regular network.
10. I understand and agree that I will not seek, nor will I receive, technical support from district staff for my personal equipment beyond connectivity to the Wireless VLAN regardless of any problems that may arise.
11. I understand and agree that the district is not responsible or liable if my personal equipment is broken, vandalized, or stolen while on district property.
12. I understand and agree that the district is not responsible or liable if my personal equipment is accessed or modified, loses data, contracts a virus, spyware, or other malware, or becomes inoperable while on district property.
13. I understand and agree that the district is not responsible or liable if my personal equipment were to injure myself or another individual or damage the property of the school or others while on district property.
14. I understand and agree to comply with all district policies pertaining to the use of my equipment in school.
15. I understand that the district may withdraw wireless VLAN privileges at any time and that violation of any of these guidelines, other District policies, or local, state, or federal laws, may result in suspension or revocation of access and possible additional sanctions.
