**Vendor Scoring: OSCWorld
 2023 Non-Public School Letter of Intent**

This service provided by Nassau BOCES is for vendor scoring of the Constructed Response Items of the **New York State 2023 3-8 ELA, Math, Science 8, and NYSESLAT** examinations by OSCWorld. This service is available for both Paper Based Testing (PBT) and Computer Based Testing (CBT).

This “per student cost” is specifically for vendor scoring of constructed response items. It does not include Nassau BOCES student fee to score, process, and report student data to SED, which is billed separately.

PROCEDURE - Paper Based Testing

BOCES provides an individual bar code label for each student examination. The label is to be placed on each student’s answer booklet. Detailed directions for packaging the exams will be included with your pre-printed student answer sheets.

- School district personnel administers the exam on the designated dates.
- After the exam, constructed response booklets are packed and delivered to OSC at their facility in Lynbrook.
- School district personnel will deliver the completed answer sheets to Nassau BOCES.
- The vendor (OSCWorld) will score the constructed response items and send the electronic files to Nassau BOCES where the data will be merged with the data from the scanned answer documents. Nassau BOCES will then process and load the data to the state reporting system.
- The vendor will use NYS certified teachers for scoring the constructed responses.

PROCEDURE - Computer Based Testing

OSCWorld will interface directly with the ScorePoint scoring application to score tests for schools that administer assessments via CBT. The procedures outlined above do not apply for Computer Based Testing.
